Payment Plan Agreement for Education Benefit

In return for Benedictine College permitting the student named above to attend classes at Benedictine College without payment in full for tuition, fees, housing and dining at the time of registration (due date), the person assuming financial responsibility (undersigned), by signing the agreement below, agrees to pay amounts owed by the student to Benedictine College in accordance with this agreement.

The Benedictine College Tuition Payment Plan (BCTPP) permits payment of charges in monthly installments over a certain agreed upon period. The actual payments are as set forth in the payment schedule above. **The payments are due on the 15th of every month of the agreement's duration; late fees will be assessed for payments not made by the due date.** Undersigned further understands either the student or the College may affect the amount if adjustments are made to charges and/or to financial aid awards during the agreement period; a new agreement may be required for certain adjustments. This written agreement supersedes any oral or written agreement made to me by any other college individual. I understand that I may prepay the entire balance at any time without penalty.

Individuals applying to the plan after the first month's installment is due must pay, in full, any installment which would have been previously due in order to bring the payments into compliance with the scheduled payments.

If the Undersigned becomes more than one month delinquent on the agreement payments, the agreement may be cancelled and payment in full will be due immediately to Benedictine College. The Undersigned further acknowledges and understands delinquent accounts are may be subject to late fees, interest charges, and reasonable collection costs as well as may be placed with a collection agency chosen by Benedictine College; notification may be given to the Credit Bureau and may result in a negative impact on their credit rating.

Benedictine College reserves the right to refuse to register any student whose student account has not been paid in full or in accordance with the payment agreement as outlined in the payment plan. Benedictine College also reserves the right to withhold grades, transcripts and any diploma for students whose student account balance has not been paid in full or does not comply with the terms of a payment plan.

I promise to pay Benedictine College, or its assignees, the amount agreed upon of _____ over the course of the payment plan. By placing my signature below, I acknowledge that the information in the above agreement is correct and that the account summary is correct. I acknowledge that I will be responsible for all costs incurred to collect such debt. This may include, but is not limited to, late fees and interest, collection costs, attorney costs and any court costs incurred. I understand that it is my responsibility to notify Benedictine College Business Office or its assignees of any agreement changes.
