SECTION 2: INFORMATION

An unemployment deferment may be available if you are temporarily unable to pay your student loan payments because you are unable to find work. During an unemployment deferment, you are not required to make payments and interest does not accrue on the loan.

In order to qualify, you must:

- Be unemployed,
- And be diligently seeking but unable to find full-time employment.

You may be eligible for a total of up to 36 months of deferment time. Unemployment deferments are posted for six (6) months at a time and then become eligible for a six (6) month grace period. You may reapply for a new unemployment deferment each year that you are unemployed.

If you have been granted an unemployment deferment by another federal student loan servicer, complete section 3. If you are requesting an unemployment deferment for the first time and do not have evidence of an unemployment deferment through another servicer, complete section 4. If you are applying for an extension of an existing unemployment deferment granted through Heartland ECSI, complete section 5. All applicants must complete section 6.
